

# Mayfield Town Council Meeting

## October 11, 2017

Regular meeting of the Mayfield Town Council was held on October 11, 2017 at 7:00 p.m. at the Mayfield Town Hall, located at 52 North Main Street, Mayfield, Utah.

Mayor John Christensen called the meeting to order and welcomed everyone to council meeting.

Pledge of Allegiance was offered.

Prayer was given by John Christensen.

Minutes for the month of September 2017 were presented to the council. After some discussion motion was made by Malynda to accept the minutes as read, seconded by Eric. (Roll Call Vote - John - Yes, Zara - Yes, Malynda - Yes - Eric - Yes)

Bills were presented for payment for the month of October 2017. After reviewing the bills motion was made by Eric to pay the bills. Seconded by Zara, motion carried. (Roll Call vote Zara - Yes, John - Yes, Eric - Yes, Malynda - Yes.

Malynda asked if Cathy Connelly is logging her hours for the Town Cabin. Malynda said she would like to see if we are generating enough money to pay for her services. Catherine stated that she will talk to Cathy.

Zara said that the Gazebo that she is having built at the Central Utah Correctional Facility should be completed and ready to deliver to the cemetery in the next two weeks.

Catherine stated that our new online payment “Secure Payments” has charged us \$2.00 for a few returned payments for insufficient funds. The council discussed the problem and John said that we need to charge our return check fee plus the \$2.00 we were charged by Secure Payments.

John updated on the council on the problems we have been having at the town well, and because of it the well at the park has been pumping to supply the water we need. The problem is now corrected.

John stated that Van is going to shut-off the water at the park and the cemetery for the winter. John told Zara that if she will need water up at the cemetery for the new gazebo she may have to haul some in.

Catherine presented to the council an updated budget report for the Mayfield Town Cabin. She said that she had Rick “our auditor” review the cabin budget with her during our town audit and we are in good shape. We have a balance of June 30, 2016 of \$3,142.79 in the cabin fund.

Catherine stated that she has had a few calls on dogs this past month. Also, people are concerned again about all the cars, tires materials etc. at the Mayfield Automotive Garage.

Malynda stated that we need to do a better job of enforcing our codes once we have them in place. Also to do a better job of interpreting what the code means, our code needs to be easier to understand and more accessible to the public.

Catherine presented the budget report for the month of September.

Malynda updated the council on the surveys. She stated that next month she will have packets with the different sections; transportation, park and recreation, public services, community vision etc. we will need to write a short article about each area or have someone write about each one for our general plan. She stated that the next step will be a work meeting for the council to put the 9 sections together from the results of the surveys.

Zara talked to the council about the cemetery. She stated that she would like the grass cut one more time. She has also had Ecolife spray for broadleaf and thistle.

Eric talked to the council about the property location at approximately 160 East 200 South, the Munson property. He said that he has had calls from concerned citizens about them living in their trailers and that they are disturbing the neighborhood. Eric would like Grant our Zoning Administrator to talk to them. Malynda stated that our Zoning Administrator has the authority to enforce anything but we do not have any consequence of enforcement in place. John stated that he thought there was something in our ordinances to help with this problem, but we do need to update our laws. John will talk to Grant.

John stated that the train is now put back together at the park. He also stated that the second phase of the Eccles Grant application has been completed and sent in. If we receive the grant the Lions will use the money to put in a cement walkway, exercise equipment and trees and shrubs around the walkway.

John updated the council on the UDOT highway 137 reconstruction project. He met with Rocky Mountain Power today about moving the 3 power poles (2 by the town hall and one by the church) either closer to the sidewalk or possibly going underground with the lines. If they decide to go underground we will have to do some of the work. UDOT and Rocky Mountain will pay for the cost of moving the power poles. The church has also been contacted about the pole by the chapel.

John said he had attended the 25 Thousand Job Tour at Snow College. It was present by Lieutenant Governor Spencer J. Cox. He said that he felt like it would be helpful for our citizens in Mayfield.
