Dog Clinic will be held on **Saturday, April 18th from 10am-12pm at the Town Hall.**

Gunnison Animal Clinic will be on site for vaccinations. If your dog(s) have their rabies vaccination you can also purchase your dog tag at the office during regular business hours. Please bring proof of rabies vaccination.

Subject to Change! We will continue to monitor the progress of the recent pandemic. If you are experiencing illness, please do not come! Make arrangements with your veterinarian for vaccination, send proof of rabies vaccination and your payment in the mail or drop it off in night drop, and your dog(s) tag and license will be mailed to you.

Water Bill this month shows a \$0.50 increase. This is due to a resolution passed in June 2018, Resolution 2017-18-A, setting the base rate to increase every year for 5 years by \$0.25. With no increase assessed in 2019, 2020 brings this increase to get on track.

COVID19 Alert:

Should there be any reports of the coronavirus in Sanpete or Sevier Counties, **White's Sanitation** has let us know that they will only be picking up their cans, no personal cans or bundles will be picked up. For the health and safety of their drivers, they will not be exiting their trucks. Take note of the information posted at the town bulletin board for further information and resources. The back page has important information about recent reports to our Town Office, please read through it. :)

There have been some reports of garbage can tipping, vandalism at our public places, and late night activity. Therefore we send you the following information from Mayfield Town Ordinance, which will be enforced:

9.08.020 Curfew – Minors – Exceptions.

A. No person under the age of 16 years shall be or remain upon any of the streets, alleys, or public places or vacant lots at night between the hours of 10:00 p.m. and 4:00 a.m. Sunday through Thursday and between 11:00 p.m. and 4:00 a.m. on Fridays and Saturdays.

B. No person of the ages 16 or 17 years shall be or remain upon any of the streets, alleys, or public places or vacant lots at night between the hours of 11:00 p.m. and 4:00 a.m. Sunday through Thursday and between 12:00 a.m. (midnight) to 4:00 a.m. Fridays and Saturdays.

C. Exceptions.

1. The above **curfew** hours shall not apply to a minor who is accompanied by a parent, guardian, or other person having legal custody of such minor person. 2. The above **curfew** hours shall not apply in cases of employment or lawful business of a minor which makes it necessary to be upon the streets, alleys, or public places. In which case, the minor person shall obtain a permit from a duly appointed law enforcement officer to be upon the streets, alleys, or public places during the above **curfew** hours. 3. The above **curfew** hours shall not apply to a minor returning home from a school, civic, or church activity. 4. The above **curfew** shall not apply to a minor exercising his or her first amendment rights, such as freedom of speech, freedom of assembly or freedom of religion.

D. Penalty. Any violation of this section is a class C misdemeanor. [Ord. 2005-06-1; code 1986 § 13-30-1-02.]

9.08.030 Responsibility of parents, guardians for curfew.

No person, guardian or other person having legal charge or custody of any person under 17 years of age shall allow or permit any such person or child, ward or other person under such age, while in such legal custody, to go or be in or upon any of the streets, alleys, or public places when such going or being in or upon such streets, alleys, or public places would be a violation by such minor person of any provision of MMC [9.08.020](#). [Ord. 2005-06-1; code 1986 § 13-30-1-03.]

9.20.010 Public property.

For the purpose of this chapter, “public property” means any publicly owned property except the traveled portion of public streets, and includes any park, sidewalk, curb or any part of any public right-of-way devoted to any planting or park-like use. [Code 1986 § 13-30-4-01.]

9.20.020 Unlawful acts. On any public property it is unlawful for any person to:

A. Willfully mark, deface, disfigure, injure, tamper with, displace or remove any building, railing, bench, paving, paving material, water line or any facilities or property and equipment of any public utilities or parts or appurtenance thereof, signs, notices or placards, whether temporary or permanent, monuments, stakes, posts or other boundary markers, wall or rock border, or other structures or equipment, facilities or public property or appurtenance whatever, either real or personal.

B. Soil or litter public restrooms and washrooms.

C. Dig and remove any sand, soil, rock, stones, trees, shrubs, or plants, down timber or other wood or materials, or make any excavation by tool, equipment, blasting or other means or agency, unless permission is obtained.

D. Construct or erect any building or structure of whatever kind, whether permanent or temporary in character, any tent, fly or windbreak, or run or string any rope, cord or wire into, upon or across any public property, except with special permit.

E. Urinate or defecate, except in the public restroom in receptacles placed there for such purpose.

F. Damage, cut, carve, burn, transplant or remove any tree or plant or injure the bark or pick the flowers or seeds of any tree or plant. No person shall attach any rope, wire or other contrivance to any tree or plant. No person shall dig in or otherwise disturb, or in any other way injure or impair the natural beauty or usefulness of any park area. This subsection shall not apply to any person authorized to perform the act proscribed.

G. Climb any tree or walk, stand or sit on monuments, fountains, railings, fences, planted areas or upon any other property not designed or customarily used for such purposes or to intentionally stand, sit or lie in or upon any street, sidewalk, stairway or crosswalk so as to prevent free passage of persons or vehicles passing over, along or across any street, sidewalk, stairway or crosswalk.

H. Drop, throw, place, discard, dump, leave or otherwise deposit any bottles, broken glass, garbage, ashes, paper boxes, cans, dirt, rubbish, waste, refuse or other trash on any public property except in waste containers provided therefor. No such refuse or trash shall be placed in any waters contiguous to any park or planted area or left anywhere on the grounds thereof.

I. Sleep on seats, benches, sidewalks, curbs, planters, wall or other areas.

J. Expose or offer for sale any article or thing or station or place any stand, cart or vehicle for the transportation, sale or display of any such article or thing, without first obtaining a license, except that the town council may exempt designated areas from this subsection by resolution on such terms and conditions as it may prescribe.

K. To beg or to go from door to door of private homes or commercial and business establishments or place himself in or upon any public way or public place to beg or to receive money or other things of value. [Code 1986 § 13-30-4-02.]
