Public Hearing was held at 6:30 p.m. to review the town budget for the coming year 2019-20 and to open the current budget 2018-19.

Eric welcomed everyone to the meeting and turned the time over to Catherine to present the 2019-20 budget. The council went over each department and projects for the coming year. (see enclosed budget)

Catherine went over resolution 2018-19 F with the council and reviewed the operations of the town departments, town fees, charges and salaries for the coming year.

Mayfield Town Council Meeting

June 12, 2019 (Recording #91)

Regular meeting of the Mayfield Town Council was held on June 12, 2019 at 7:00 p.m. at the Mayfield Town Hall, located at 52 North Main Street, Mayfield, Utah.

Pledge of Allegiance was offered.

Prayer was given by Mike

Council member Eric welcomed everyone to the meeting.

Harvey Sorensen was at the meeting to discuss with the council several items. He is concerned about the taste and smell of our town water. Aaron updated him on our new water project and that we are working on improving our water. Harvey talked to the council about his major concerns with the town cemetery and mainly his family graves and his baby grave. He stated that his family's graves has no grass and is covered with weeds, he asked why the cemetery is not being watered. The council have also been concerned and we are working on correcting the problems at the cemetery. He also stated that someone has broken a piece off of one of their headstones at the cemetery

Harvey thanked the council for the handicap signs that were put in by his home but they still have a major problem with cars and motorcycles going to fast around the corner by their home and up the road. He asked the council to please put in 4 - 15 mph speed limit signs. The council asked Catherine to order the speed signs.

Seth Olsen was at the meeting to talk to the council about the water connection on his property that he has purchased from Keith Larsen. He stated that there is a meter box but it is not connected to the new system. He does not want to pay the impact fees and connection fees. Catherine stated that Van had checked our system blueprints back to 1988 and they do not show that property having a water connection. She also had talked to the attorney and he said that Seth would need to somehow show proof that at one time that property was connected to the Mayfield Town water system. After some discussion the council said to have Mike Madsen dig it up to see if he can tell if it had been connected to the town system.

Minutes for our public meeting for funding from CIB and minutes from the public meeting to review the changes and updating to our Mayfield Town Zoning Ordinances, and also minutes for the month of May 8, 2019 were presented to the council. After some discussion, motion was made by Malynda to accept the minutes for each meeting, seconded by Aaron. (Roll Call Vote - Mike - yes, Eric - yes, - Aaron - yes, Malynda - yes).

Bills were presented for payment for the month of June 2019. After reviewing the bills motion was made by Mike to pay the bills, seconded by Aaron, motion carried. (Roll Call vote Eric - yes, Mike - yes, Aaron - yes, Malynda - yes).

Catherine stated that Grant Hansen was concerned that Afton Hansen's grave has never had grass.

Catherine went over the certified tax rate for the coming year with the council. Our certified tax rate for 2019-20 is 0.000671 with the budgeted revenue \$16,831.00.

Catherine stated that we have 2 openings for the upcoming election in November. Aaron Peterson has registered to run for another 4 years and Jake Dyreng has also registered to run for a 4 year term in November.

Catherine spoke to the council about agreements that the town made with Bud Harris and Mark Hopkins back into 2008 for free water connections to the town system if they would allow the town to run pipe for our new water system project. Catherine said she will look into it more and get back to the council.

Catherine talked to the council about a special use permit with Manti-LaSal national Forest.

Catherine had received a letter from the Bureau of Land Management stating that the town is the surface owner of all or a portion of the lands in parcel number UT 0919 - 067 in Sanpete

County,Utah. The federal oil and gas rights may potentially be offered in a competitive oil and gas lease sale scheduled for September 9, 2019.

The Council went over the budget for 2019-20 year. They also discussed town fees and salaries for the coming year. Malynda said that she would like to have a time study done before wages and salaries can be determined. Malynda also talked about increases for the Mayor and council. The council discussed putting an article in the newsletter asking for public input concerning giving the council and mayor a raise.

After reviewing the budget for 2018-19 year and resolution 2018-19F for the operations of all town departments and town fees, motion was made by Malynda to accept resolution 2018-19 F with corrections. Seconded by Aaron, motion carried. (Roll Call vote Eric - yes, Mike - yes, Aaron - yes, Malynda - yes). The council review resolution 2918-19 G to open the current budget 2018-19 with the following changes to our budget:
