

# Mayfield Town Council Meeting

## August 18, 2015

---

Regular meeting of the Mayfield Town Council was held on August 18, 2015 at 7:00 p.m. at the Mayfield Town Hall, located at 52 North Main Street, Mayfield, Utah.

Billie Coates welcomed everyone to the meeting. Pledge of Allegiance was offered and the prayer was given by Catherine.

Minutes were read for the months of June and July. After some discussion motion was made by Desirae to accept the minutes with corrections. Seconded by Zara, motion carried.

Bills were presented for payment and after reviewing the bills motion was made by Billie to pay the bills. Seconded by Zara, motion carried.

Zara told the council about a volunteer program that the church has started in some areas and felt like it would be a good program for the town to look into.

Van stated that the water levels are down at the springs. The council also asked Van about making sure the trees at the park and cemetery are getting the water they need.

Zara stated that there are still a lot of weeds at the cemetery, and was wondering if we could spray again. Zara also said that there are projects at the cemetery that need to be done this fall so the cemetery is ready for the spring projects she has planned

Van said that Aaron Peterson and Adam Peterson's meters are deep in the ground because of built up there yards. Van said that he would like to get Mike Madsen to come to raise up those meters.

The council talked about the new sidewalk project and what needs to be done to move forward with it. The council wants to wait to have Mike do the meters until we are ready to do the sidewalk also because we will need to have some backhoe work done to complete the project.

Zara said that she has had a few calls on the Christenburg road from people that are having a hard time getting out of their driveways from the new road being built up it is causing a dip in some of the driveways. Billie stated that Garrick Willden said to have anyone with concerns to come into the town hall and sign a paper and he will take care of it.

Catherine talked to the council about the new garbage fee that went into affect July 1<sup>st</sup>. She understood that the new landfill rate was \$4.00 a month and when she received the bill it was only \$3.60. After some discussion the council felt like we need to lower our garbage fee by .50 per month.

Catherine stated that J L Larsen had called and would like to connect the lot that he has built his garage on to culinary water without paying the impact and connection fees. After going over the ordinances and discussing the situation the council felt that he would need to pay all fees to connect to the meter on that lot.

Zara updated the council on the improvement projects that she is working on at the cemetery. She stated that she would like to use some of the perpetual care funds to complete what she has planned. She stated that we cannot find any ordinance or resolution stating how the perpetual care fund was set up so Catherine is going to do some research to see how other communities handle their funds.

Zara talked about needing volunteers to help with several projects. She stated that she would like to put in the letter what we have accomplished this year and what we have plans to do in the future. Then ask for volunteers or cash donations from anyone who would like to help with some of the improvements. The council felt like that was a great idea.

Catherine asked the council to sign the "Disclosure Statements" that were in their packets.

Catherine reviewed with the council resolution 2015-16A "Records access and Management". After some discussion motion was made by Desirae to accept Resolution 2015-16A, seconded by Zara. Motion carried.
